What I am trying to get to is the page David Jeremiah screen shared about the three versions of "United States" that he is evidently relying upon. For your information, when we really delved into it, we found over 350 entities using the name "United States". There were at least four (4) major entities just with our respective government structures that used the name "United States" over time. The Union States from 1776 to 1851 used "the United States" and from 1851 onward used "The United States". The Municipal government subcontractor used the name "United States" throughout, 1790 to present. The American Federal Republic used the name "United States" from 1787 to 1871. The District of Columbia Municipal Corporation used the name "United States" from 1871 to 2015 and used Latin naming conventions for commercial purposes "UNITED STATES" to designate the commercial corporation they created to conduct commercial business. This latter entity is what we see described at 28 USC 3002 (15) A.

The so-called "Organic Act" attempted to legitimize a civilian government to operate "for" the "missing" American Government during the supposed "interregnum" and used a District of Columbia Municipal Corporation as a means to do this. Municipal city-state governments can operate as civilian governments and so, we wound up with the District of Columbia Municipal Corporation posing as "the United States" and the Municipality of Washington, DC operating as a foreign international independent city-state.

None of this was necessary nor justified and arose purely and simply because the two remaining Federal Subcontractors failed to disclose the circumstance to the American Public; they instead colluded together unofficially, and since 1937 -- officially -- to continue a pretense of war and justification for continued and otherwise blatantly illegal mercenary occupation of our country by the British Crown

Corp franchise doing business as the United States of America, Inc., U.S.A., Inc., and various other similar names.

When the UNITED STATES went bankrupt in 2015 it did so with our assets still held in trust, which created the situation that led to David Jeremiah having everything dumped in his lap.

The Perpetrators were in the same position as a pawn shop owner caught with a lot of stolen goods, so they had to come up with a narrative and an exit plan. What you are seeing as the USCPB is their plan.

They, as usual, didn't see fit to notify us, the actual owners of all the loot they took out of this country --- and even though they have cause to know that I prompted the investigation that led Pope Francis to bankrupt the UNITED STATES, they, or their Agents, are still trying to do business with Donald Trump?

The idea that we are all chasing a vanished "republic" is a red herring. It's true that the American Federal Republic vanished. So did the original Confederation of States-of-States. **Neither one of those is vital to our government.** We function perfectly well without a Confederation or a separate Federal Republic. We did so officially for five years, 1776-1781, and if necessary can conduct our own business without the need for these instrumentalities and subcontractors. For the time being, that is what we have chosen to do -- we call it "mowing our own lawn". The Federation of States and our State Citizens -- the Parties that delegated the Enumerated Powers, have elected to retain the powers that were once delegated to the American Federal Republic and to do the work ourselves until our Congressional Delegations meet to examine the treaties involved. As things stand, the other Principals are in Breach of Trust and in violation of the "good faith service" guarantees provided under all three Federal Constitutions.

We fully recognize the attempt to shift all business activities into the realm of commerce and place it under the jurisdiction of the air, which has been recently redefined and expanded as a galactic space and a new jurisdiction of commercial

law designated Uc-1 and attendant courts; Judge Adriaan Rudolph Fondse is our Judiciary Guardian in this new jurisdiction as we open Uc-1 courts.
